# How do I inform the General Fraternity of my CAS selection?

Selecting your chapter's Chapter Accounting Standards Compliance option is an easy two-step process, depicted by a stoplight.

The steps can be completed at <u>http://my.betathetapi.org</u>

**First**, following *Keystone*, each chapter must select their option on my.betathetapi.org for the upcoming/next academic/fiscal year. Making this selection will move your chapter's CAS stoplight from Red to Yellow.

**Second**, the chapter must submit the required documentation. To complete this step for all three options chapters should:

- Billhighway
  - Transfer all chapter cash into Billhighway and actively use the system (100% of financial transactions occur within Billhighway)
- Accounting Professional
  - Submit the certification letter to the General Fraternity. A scanned copy can be emailed directly to <u>dan.fogle@betathetapi.org</u>
- Self-Reporting\*\*
  - Submit financial statements, Form 990, 990T, and forms 1099 upon completion of the fiscal year. These reports are due prior to November following the close of the fiscal year.


Completing this second step will let the General Treasurer know your chapter is ready for approval. Following confirmation of your submitted information, your information will be reviewed. Upon approval, your CAS status will change to Green.



### Chapter Accounting Standards (CAS) for <current/next FY>




Starting in 2011, each chapter must select a financial reporting option to maintain compliance. You must select a reporting option below by 4/15/<year>.


