REPORTING REMINDERS

- · Maintain up-to-date membership and officer rosters as changes occur.
- · All Grade Reports are due within 90 days of the end of the term.
- · All End-of Term Reports are due within 30 days of the end of the term
- Register all new members within 72 hours of joining either the first new member function (ceremony, meeting, orientation, etc.) or moving into the chapter house.
- · Report all initiations online within 72 hours of the ceremony.
- · Report all potential risk management incidents within 24 hours.
- Authorized chapter officers for online reporting include president, executive vice
 president, vice president of brotherhood, vice president of administration, vice president
 of education, vice president of finance and vice president of recruitment.

FINANCIAL INFORMATION

- If payment in full is not received within 30 days of the billing date, a delinquent chapter will incur the standard finance charge of 1.5% per month [Chapter X, Section 2 of The Code]. Exception: Fall dues, heritage fees and insurance fees are billed July 31 (semester schools) and August 31 (quarter schools) to allow for adequate chapter planning and roster maintenance by September 30. Spring dues, heritage fees and insurance fees are billed December 31 (all schools) to allow for roster maintenance by February 28.
- Keystone Conference fees are billed in \$315 monthly installments from September 30 to January 31 for five officer registrations (4 winter, 1 summer).
